The Kingdom of Cambodia has received financing on grant from the Asian Infrastructure Investment Bank (AIIB) towards the cost of Integrated Water Resources Management Project (IWRM) in order to provide the preparation of project. Ministry of Water Resources and Meteorology (MOWRAM) as the Executing Agency (EA).

IWRM, is supporting the Royal Government of Cambodia's strategy to enhance economic growth in the project area through facilitate the preparation of the proposed IWRM Project designed to improve the likelihood of targeted reviver basin communities through an integrated water resource management approach that addresses resilient infrastructure, sustainable asset management, and climate adaptation needs in the targeted river basins.

Scope of Work:

The main activities of the socio-economic baseline survey are to: (i) collect and analyse the relevant information of existing situation of the project's targeted beneficiaries and related stakeholders; and (ii) assess the potential impacts of the project on the situation of the households and communities in the project area, including Kbal Hong Irrigation Scheme in Pursat; and Kanghot Irrigation Scheme sub-project in Battambang Province.
