- 1 The Royal Government of Cambodia (RGC) has received a credit from the World Bank toward the cost of Road Asset Management Project II Additional Financing, and it intends to apply part of the proceeds of this credit to payments under the Contract for the Supply and Installation of IT Equipment (Hardware and Software).
- 2 The Ministry of Public Works and Transport now invites sealed bids from eligible and qualified bidders for Supply and Installation of IT Equipment (Hardware and Software).
- 3 Procurement will be conducted through National Competitive Bidding Procedures and under the laws and regulations governing public procurement within the Kingdom of Cambodia, in accordance with procedures set forth in the Procurement Manual for Externally Financed Projects/Programs in Cambodia, May 2012 and the World Bank's Procurement of Goods and Works Guidelines January 2011 (Revised in 2014).

- 10 All bids shall be accompanied by a Bid Securing Declaration as described in the Instructions to Bidders.
- 11 The Royal Government of Cambodia and/or World Bank will respectively declare a bidder ineligible either indefinitely or for a stated period of time, to be awarded a contract financed by the Royal Government of Cambodia and/or World Bank respectively, if it at any time determines that the bidder has engaged in corrupt or fraudulent, coercive, collusive or obstructive practices in competing for or in executing a contract.
- 12 The Bidders are requested to submit as part of their bids the statement of Ethical Conduct and Fraud and Corruption and in case of misleading information or non-adherence to the Fraud and Corruption provision of the bidding documents, the Bidder shall be pursued by the Government of Cambodia/ or the IDA.
